# Project Overview





## East and West Campus Certify the Final EIR for the Facebook Campus Project

- EIR certification is relevant for the **entire** Project, including Phase I – East Campus and Phase II – West Campus
- No new significant environmental impacts, no new significant information, and no substantial increase in severity of earlier identified impacts
- Attachment B in staff report



## **East and West Campus Certify the Final EIR for the Facebook Campus Project – Cont.**

### Key Differences between Draft and Final EIR

- Biological Resources – additional mitigation measures
  - Nesting birds surveys
  - Burrowing owl surveys and bird safe design standards
- Transportation – intersection impacts/mitigations
  - Middlefield and Lytton – no longer significant and unavoidable impact
  - Marsh/Middlefield mitigation measure revised
- Air Quality – additional mitigation measure
  - Installation of Cogenra system on Bldg. 11



# Middlefield Road and Marsh Road Mitigation

- On-going discussions with the Town of Atherton
  - Outreach began prior to release of Draft EIR
  - Correspondence included as Attachments R and S
- Mitigation measure identified in EIR mitigates impact of Project
- Per CEQA, applicant is not required to address existing intersection deficiencies
- Separate presentation by Chip Taylor



## **East Campus** Adopt the Statement of Overriding Considerations and Mitigation Monitoring and Reporting Program

- Statement of Overriding Considerations (SOC) and Mitigation Monitoring and Reporting Program (MMRP) required to grant land use entitlements
- SOC - Substantial project benefits that outweigh significant environmental impacts
- MMRP – responsibility and timing for mitigations
- Attachments C and D in staff report



## East Campus Adopt the Development Agreement

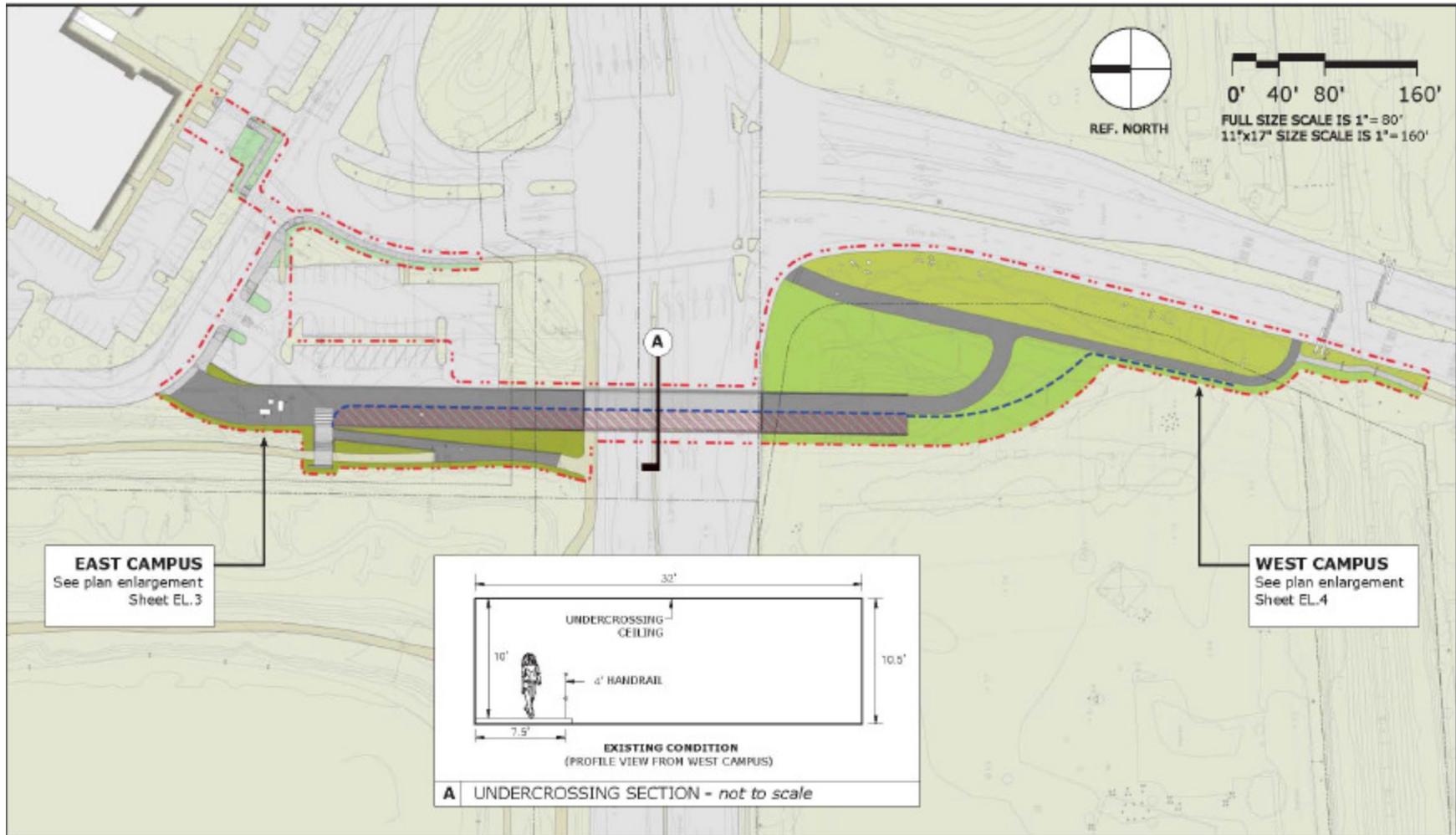
- Legally binding contract that delineates terms and conditions of a project
- Council Approved term sheet is the framework
- Attachment F in staff report
- East Palo Alto term sheet – approved by EPA Council May 1st

● ● ● | **East Campus** Adopt the Amended  
and Restated Conditional  
Development Permit (CDP)

- Sun CDP approved in 1992
- Amended and Restated CDP would implement a vehicle trip cap to accommodate increase of employees
- CDP specifies development standards, permitted uses and conditions of approval

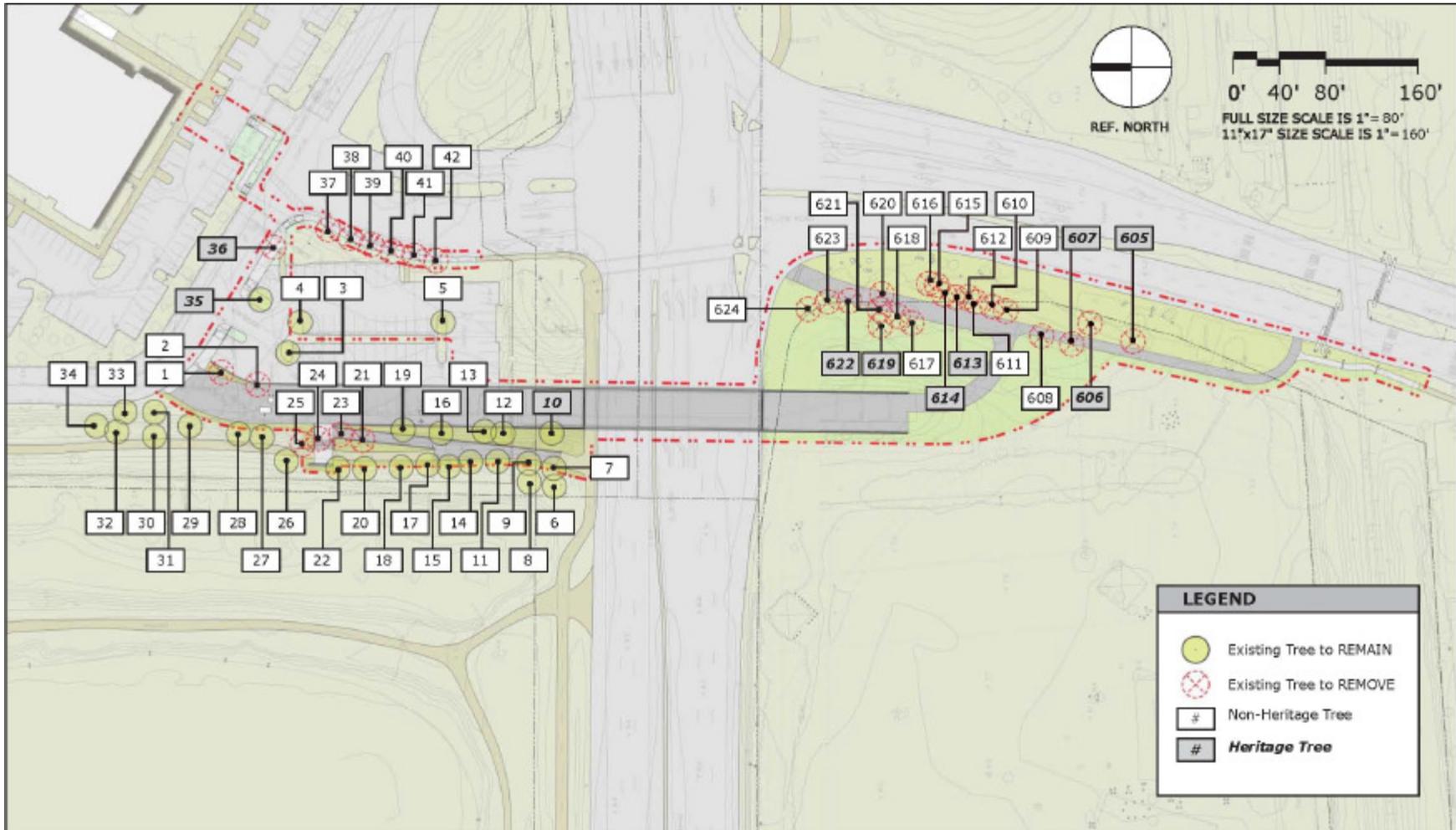


# Phase I Conceptual Undercrossing Plans – Sheet EL.2

# Staff Recommendation
