### NOVEL CORONAVIRUS, COVID-19, EMERGENCY ADVISORY NOTICE

On March 19, 2020, the Governor ordered a statewide stay-at-home order calling on all individuals living in the State of California to stay at home or at their place of residence to slow the spread of the COVID-19 virus. Additionally, the Governor has temporarily suspended certain requirements of the Brown Act. For the duration of the shelter in place order, the following public meeting protocols will apply.

Teleconference meeting: All members of the Planning Commission, city staff, applicants, and members of the public will be participating by teleconference. To promote social distancing while allowing essential governmental functions to continue, the Governor has temporarily waived portions of the open meetings act and rules pertaining to teleconference meetings. This meeting is conducted in compliance with the Governor's Executive Order N-25-20 issued March 12, 2020, and supplemental Executive Order N-29-20 issued March 17, 2020.

### F. Public Hearing

- F1. Use Permit and Architectural Control/O'Connor Tract Co-operative Water Company/211 Oak Court: Request for a use permit and architectural control to add a new manganese treatment system to an existing public facility water treatment system located in the R-1-U (Single Family Urban Residential) zoning district. The new system would include a 20,000-gallon raw water blending tank, a 10,000-gallon backwash storage tank, a multimedia filter system, a 192-square-foot equipment and controls building, and associated equipment. The existing diesel generator is proposed to be replaced, and sodium hypochlorite would be used for the water treatment, both of which require use permit review for the use and storage of hazardous materials. The application also includes a use permit request to exceed Noise Ordinance noise levels along the right property line for monthly testing of the generator. ([Staff Report #21-028-PC](#))

## I. Adjournment

If you challenge any of the items listed on this agenda in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City of Menlo Park at, or prior to, the public hearing.
