** EV (Electric Vehicle) requirements also apply to many projects. In addition, certain single-family residential properties may convert an existing garage/carport into SDU (Secondary Dwelling Unit) use and provide replacement parking in alternate configurations, including uncovered and tandem. See a planner for more information about either the EV or SDU garage conversion topics. Bicycle parking requirements also apply in certain districts- see Ordinance for details.

X	Conditional Development Combining District--For a parcel of land in excess of one acre (or $\geq 20,000$ square feet, if certain Below Market Rate (BMR) Housing requirements are met), in any district (except for SP-ECR/D), this district permits adjustment of the underlying District requirements in order to secure special benefits possible through comprehensive planning of such large development.
AAGP	Allied Arts Guild Preservation District--This district's purpose is to protect and enhance the historic character and function of the Allied Arts Guild.
FP	Flood Plain, for Baylands, Marshlands--Appropriate uses, such as agricultural uses and public or private recreation facilities are allowed in this district.
H	Historic Site District--This district is used to promote preservation of historic sites and structures.
LS	Life Sciences--Area for R&D (Research and Development) and light industrial uses (esp. bioscience and biomedical product development and manufacturing), with supporting office
O	Office--District accommodating large-scale office, plus retail/service and some light industrial/R&D uses.
O-S-C	Open Space and Conservation--This district is used to protect and preserve open space land.
P-F	Public Facilities--Includes all public facilities owned or used and operated for governmental purposes by the City, the County, the State, the Federal Government, a public school district, and any other governmental agency.
R-1-U (LM)	Single-Family Urban Residential (Lorelei Manor)--Provides unique regulations for a particular neighborhood.
R-L-U	Retirement Living Units--This district provides special development regulations for housing for the elderly.
R-MU	Residential Mixed-Use--Intended to provide high-density housing to complement nearby employment, plus associated retail/service and office uses.
SP-ECR/D	El Camino Real/Downtown Specific Plan--Uses, development regulations, guidelines, definitions, off-street parking requirements, and other parameters for public and private development are established through the El Camino Real/Downtown Specific Plan.

In all zoning districts, the construction of a new building or the extensive remodeling of an existing building on a property which has a substandard lot width, depth and/or area may require use permit and/or architectural control approval by the Planning Commission prior to applying for a building permit.
